## **1. INTRODUCTION**

- ii. KFC may, at its discretion, may extend the deadline for submission of quotations through the issue of an addendum, in which case all rights and obligations of **KFC** and the quotations previously subject to the original deadline shall thereafter be subject to the new deadline as extended.

#### **B) PROCESS CONFIDENTIALITY**

- i. Information relating to the examination, clarification, evaluation and comparisons of quotations and recommendations concerning the award of contract shall not be disclosed to suppliers or other persons not officially concerned with such process until the award of contract is announced.
- ii. Any effort by supplier to influence KFC in the process of examination, evaluation, comparison of quotations and decisions concerning award of contract may result in the rejection of that supplier's quotation.

#### **C) CLARIFICATION OF QUOTATIONS**

1. To assist in the examination, evaluation and comparison of quotations, KFC may ask suppliers, individually, for clarification of their quotations, including breakdown of unit prices. The request for clarification and the response shall be in writing or by cable, facsimile or e-mail, but no change in the price or substance of the quotation shall be

sought, offered or permitted except as required to confirm the correction of arithmetical errors discovered by the employer during the evaluation of the quotations.

2. No supplier shall contact KFC on any matter relating to his/her quotation from the time of the quotation receipt to the time the contract is awarded. If a supplier wishes to bring additional information to KFC's notice, s/he shall do so in writing.

#### **D) CORRUPT FRAUDULENT PRACTICES**

Kenya Film Commission requires that suppliers observe the highest ethical standards during the procurement process and execution of contracts. In pursuance of this policy, Kenya Film Commission:

Defines, for the purposes of this provision, the terms set forth below as follows:

- ◆ **“Corrupt practice”** means the offering, giving, receiving or soliciting of anything of value to influence the action of an official in the procurement process or in contract execution; and
- ◆ **“Fraudulent practice”** means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the company, and includes collusive practice among suppliers (prior to or after quotation submission) designed to establish quotation prices at artificial non-competitive levels and to deprive the Procuring entity of the benefits of free and open competition.
